Entry Fee: Category A - R250 Category C R50

All entry fees must be paid in by 3 February, and competition cards handed in at 13:50, 7 February, thereafter, no competition card will be accepted.

No competitor will be allowed to participate in competition if there are competition fees or competition cards outstanding

**CONGRATULATIONS!!** To the gymnasts who made the Top Ten in the country, list. Please see appended list for names, gymnasts appear in no specific order on list. It remains the responsibility of Regions / Coaches to inform Cheryl as soon as possible but not later than **Friday 24 January** if a competitor cannot compete. **If a coach fails to inform Cheryl before or on 24 January of withdrawal of gymnast, he/she will be liable for the entry fee. All withdrawals after 24 January must be accompanied by a doctor's certificate.** Reserves are eagerly waiting to hear whether they could compete and have to make travel and accommodation arrangements.
