**RE: UPDATED WC & WAGC TEAM – BULGERIA 2017
TRAMPOLINE, DOUBLE-MINI & TUMBLING TEAMS**

Dear Coaches

Please see the selection of the WC and WAGC team for both trampoline and tumbling, which must still be approved by the SAGF. We have selected the gymnasts who met the difficulty criteria or who had one or less point difference from the required difficulty criteria. The only exception made was to the age group 15-16 as this age group is eligible to participate in the Youth Olympic Games. These are therefore our priority gymnasts, who do all have a portfolio. They need the opportunity to compete in this competition as preparation and experience for the YOG. If there are any queries regarding the selection then please phone me ASAP.

As always execution remains a challenge and as such we would highly recommend that coaches do not increase any gymnast's trial difficulty, especially in cases where the difficulty is far more than required but rather pay attention to improving execution. Gymnasts will be re-evaluated during the Gym Games and we are hoping to see a huge improvement in this area.

Unfortunately neither the SAGF nor the trampoline account has the funds available to pay the costs for the required coaches and judges – This means that each gymnast will be charged a maximum of R5000.00 towards these costs. We need to submit teams, with entry fees and 50% accommodation costs next week. Leanne will make the deposit amount known which will need to be paid by next week, Districts must kindly confirm by Sunday 13th August whether there are any withdrawals.

Budgeted Costs (Accommodation, Meals, Flight)

- 1) One entry fee R28, 275.00
- 2) Two entry fees R30, 575.00
- 3) Three fees R32, 875.00
- 4) Four entry fees R35, 375.00

Entry requirements for South Africans: South Africans need a visa to enter Bulgaria. A passport valid for at least six months on entry is required and a visa will only be issued if blank pages are available.

NB The costs quoted do not include for competition attire approx. R3500.00 and the cost of a Bulgarian Visa.


