## **RE: TRA & TUM WC & WAGC 2<sup>ND</sup> TRIAL INFORMATION**

Dear Clubs.

Please find attached the selection document for Trampoline & Tumbling for Senior World Championships competitors & Junior World Age Group Games competitors.

The TC has received the directives from the FIG for the World Championships and would like to bring to your attention the changes to the deadline dates we initially set.

<b>Payment Commitment Date</b>	<b>To Be Paid To SAGF</b>
<b>March 15</b> – Trial Entry Fee	R1000.00 for two trials
<b>July 25</b> - 1st Deposit	R15,000.00
<b>August 25</b> - 2nd Deposit	R15,000.00
<b>September 25</b> - Final Payment	Remaining Amount

We are still waiting for the SAGF budgeted costs and will inform all should this differ to the budget we provided in the selection criteria.

### **Important Information.**

- a. There is intent to participate form that must be completed and returned to us with all the required documentation by the deadline date provided, for both gymnasts, coaches and judges who have the correct qualifications. This is not required if the intent to participate was completed for the first trials and all the required information submitted.
- b. If a gymnast didn't participate in the 2018 SA Gym Games, a letter of explanation must be provided.
- c. The entry fee for both trials should already have been paid – all clubs to submit proof of payment to me by no later than Sunday 16<sup>th</sup> June 2019. **Failure to do so will result in your gymnast/s not being allowed to participate.**
- d. **Gymnasts with outstanding amounts with South African Gymnastics Federation will have to pay in full any outstanding amounts before the team is announced in order to be eligible for the 2019 WC & WAGC Team.**

- e. It is the clubs responsibility to ensure that all their gymnasts accounts are paid up to date. Please contact Stacey who can tell you if there is any outstanding amounts.
- f. All entries MUST be entered on the SAGF online system on or before 24h00 on Sunday 16<sup>th</sup> June 2019. Should the online system have to be opened for late entries - each entry will incur a R400.00 penalty over and above the entry fee.

**It is crucial that you read and comply with all requirements shown under the “Important Information” section, as we will not be requesting this information again. Should any of the documents required not be received before the trials – this will render a gymnast not being eligible for selection.**

Trial Date: Monday 1 July 2019 Time: 09:00-10:30



Entry Fee: Trampoline R670.00 & R335.00 (PDI) for one or more events.  
Tumbling R670.00 & R335.00 (PDI) for one or more events.  
The full entry for both trials should already have been paid by the 1<sup>st</sup> trials.  
Clubs to forward me POP by no later than Tuesday 11<sup>th</sup> June 2019.

Closing Date: Entries MUST be submitted online – on or before Monday 10<sup>th</sup> June 2019.
